## ACCOUNTING SERVICES

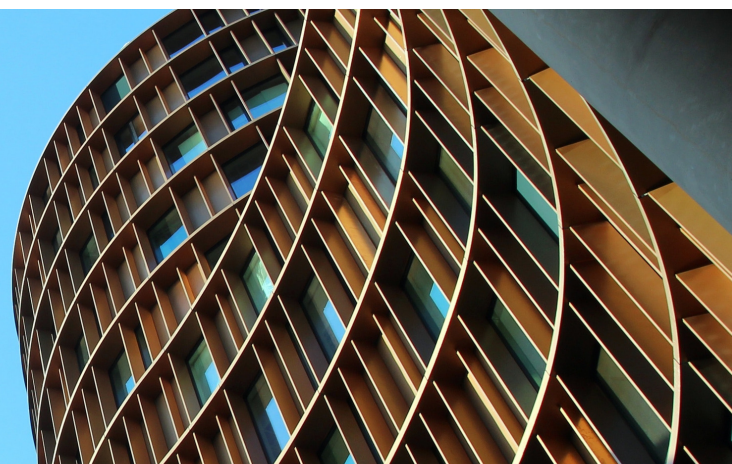

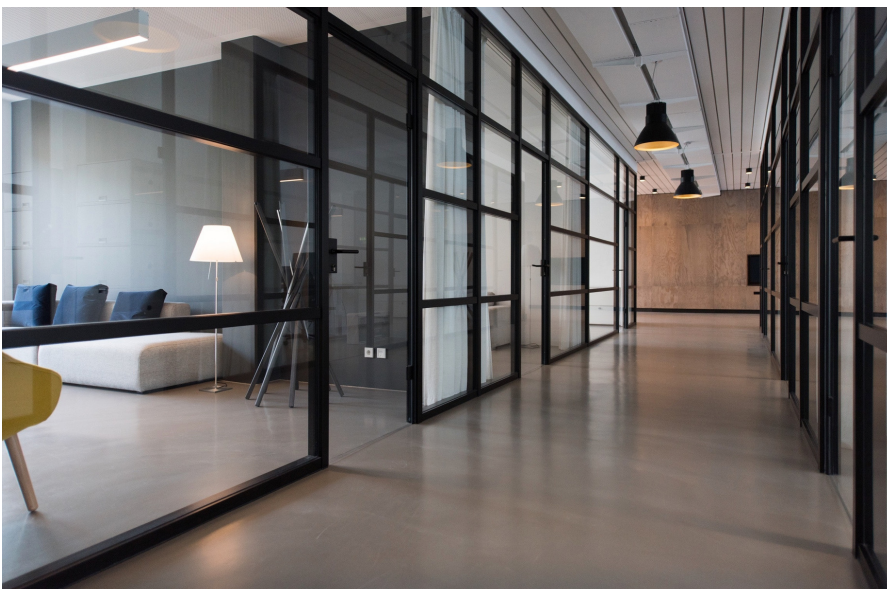
